The statement is made at the request of the Stock Exchange.

The board of directors of Regal has noted the recent increase in the trading volume of the ordinary shares of Regal and wishes to state that it is not aware of any reasons for such increase, save that (i) Paliburg, of which Regal is the listed associated company, has acquired a total of 10,620,000 ordinary shares of Regal at an average price of HK\$0.4875 per share on the Stock Exchange today; and (ii) Dr. Francis Choi, Vice Chairman and Non-Executive Director of Regal, has acquired 2,400,000 ordinary shares of Regal at a price of HK\$0.48 per share on the Stock Exchange today.

The statement is made at the request of The Stock Exchange of Hong Kong Limited (the "Stock Exchange").

The board of directors (the "Board") of Regal Hotels International Holdings Limited ("Regal") has noted the recent increase in the trading volume of the ordinary shares of Regal and wishes to state that it is not aware of any reasons for such increase, save that:

- (i) Paliburg Holdings Limited ("Paliburg"), of which Regal is the listed associated company, has acquired a total of 10,620,000 ordinary shares of Regal at an average price of HK\$0.4875 per share on the Stock Exchange today; and
- (ii) Dr. Francis Choi Chee Ming ("Dr. Francis Choi"), Vice Chairman and Non-Executive Director of Regal, has acquired 2,400,000 ordinary shares of Regal at a price of HK\$0.48 per share on the Stock Exchange today.

After such acquisitions of ordinary shares in Regal by Paliburg and Dr. Francis Choi, the interests of Paliburg in the ordinary shares of Regal have increased from 45.33% to 45.46%, and Dr. Francis Choi presently holds 0.03% interests in the ordinary shares of Regal.

The Board also confirms that there are no negotiations or agreements relating to intended acquisitions or realisations which are discloseable under rule 13.23 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules"), neither is the Board aware of any matter discloseable under the general obligation imposed by rule 13.09 of the Listing Rules, which is or may be of a price-sensitive nature.
