## JOINT ANNOUNCEMENT

### FURTHER DELAY IN DESPATCH OF CIRCULARS

References are made to (a) the joint announcements dated 22 March 2026, 24 April 2026 and 30 April 2026 issued by Century City International Holdings Limited (“**Century City**”), Paliburg Holdings Limited and Regal Hotels International Holdings Limited (“**Regal**”) in relation to the Transaction; (b) the joint announcement dated 15 April 2026 issued by Century City and Regal in relation to the delay in despatch of circulars in relation to the Transaction and (c) the joint announcement dated 23 April 2026 issued by Century City and Regal in relation to the grant of waiver from strict compliance with Rule 14.41(a) of the Listing Rules (collectively, the “**Joint Announcements**”).
