Mr. Jimmy Lo Chun To, aged 27 — Appointed to the Board in 1999. He is also a director of CCIHL and PHL. Mr. Jimmy Lo graduated from Cornell University, New York, U.S.A. with a degree in architecture. He has been involved with the design of the property and hotel projects of the Group. He is also actively involved in the management of the newly established joint venture IT business of the Century City Group. He is the son of Mr. Lo Yuk Sui and Mrs. Kitty Lo Lee Kit Tai.
